All Green Recycling, Inc., a leader in electronic waste recycling, announced today that it will be relocating its corporate headquarters from New Brunswick, New Jersey to Charlotte, North Carolina. The company is in the process of upgrading a facility at 321 Atando Avenue for use as a corporate office, research and development facility, and its production and warehousing operations. The move will create 20 jobs in Charlotte.

All Green Recycling is a private, woman-owned business founded in 2012. It is an R-2 RIOS 2013 electronics recycler. Focused on the recycling of e-waste, the company provides its clients with e-waste management services that include collection services, data security, demanufacturing and repurposing of components from a wide range of high-tech consumer and industrial electronics. The company also utilizes its proprietary technology to recover precious metals from electronic devices, computer chips and circuit boards. This technology, unique in the industry, has no discharges and operates within a closed-loop system giving both economic and environmental benefits. The company has also developed an environmentally friendly process without smelting to recover and repurpose lead from televisions and CRT monitors. All Green Recycling began its work in Charlotte in August 2014 and has seen rapid growth in its business and client base.

"States like North Carolina are increasingly adopting laws governing the responsible handling of e-waste to ensure that environmental impacts from hazardous materials and toxins are minimized or eliminated," said All Green Recycling Chairman and CEO Carol Jegou. "One hundred percent of all materials processed through All Green are responsibly recycled. All Green Recycling is on the leading edge of technological innovation with processes that comply with the highest industry and regulatory standards. Our company serves a diverse and growing list of corporate clients. It also now serves the recycling needs of six counties and three cities in North Carolina."
